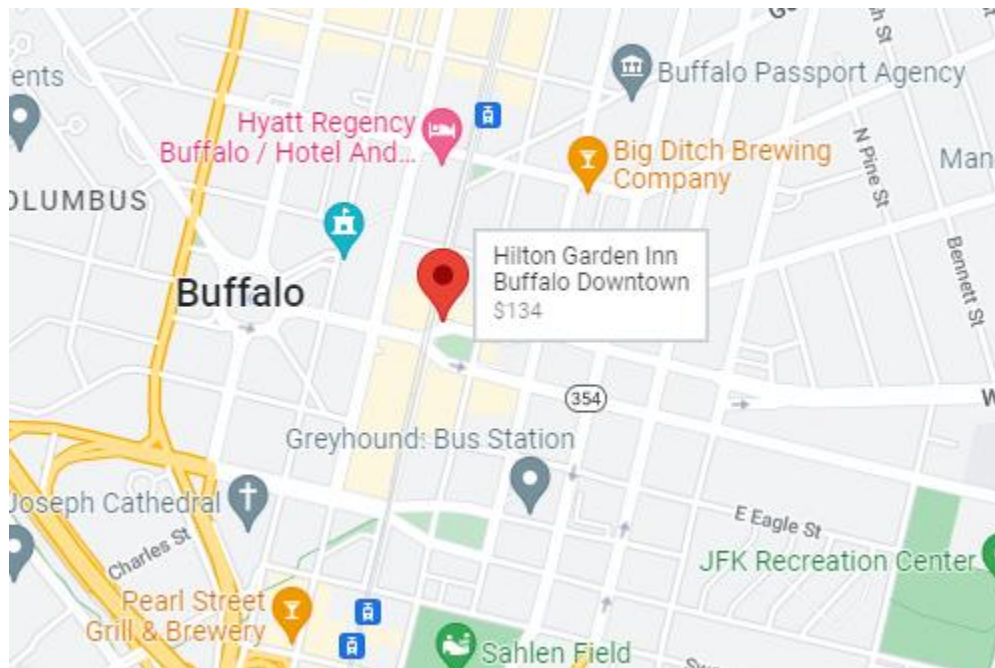
Standard Q/Q. The Hotel's room rates are subject to applicable state and local taxes in effect at the time of check out.
